FLOOR PLAN



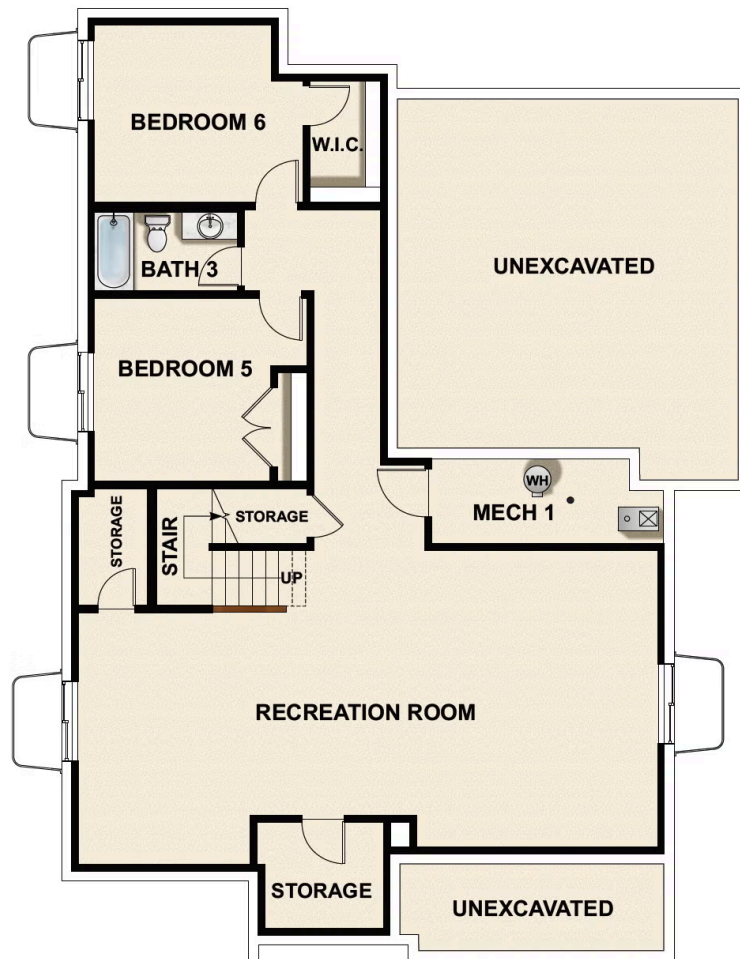
